Throughout the Section A notes, the light orange colored text was changed to a red color that meets the ADA requirement for contrast.

On Sheet A2, the yellow guidance text was updated and the SPECIFICATIONS note was removed. The SPECIFICATIONS note will no longer be in Section A. The Bid Letting Office will include a specifications note and link to the electronic specifications webpage in the Notice to Contractors.

On Sheet A3, Commitment A1 was updated to add language /the plans after Section B Grading Plans and add guidance to send wetland files to designer to be incorporated into the plans. The Specifications reference was updated from Section 7.21 D to Section 7.18.

On Sheet A7, Commitment E updated language from certification to Authorization and updated the form link, updated the EPA permit year. In Commitment F we added a heading on the table of seasonal restrictions, corrected language, coldwater spelling. In Commitment H, we removed first half of the first sentence in Action Taken. Reformatted paragraphs.
