

## **Section D – Erosion Control Notes have been updated.**

On Sheet D3, the products and manufacturers were removed from the TOPSOIL AMENDMENT note. A note was added stating that this item will be from the approved products list and a link to the approved products list was also added.

On Sheet D3, the products and manufacturers were removed from the MYCORRHIZAL INOCULUM note. A note was added stating that this item will be from the approved products list and a link to the approved products list was also added.

On Sheets D3-D4, the products and manufacturers were removed from the FERTILIZING note. A note was added stating that this item will be from the approved products list and a link to the approved products list was also added.

On Sheet D6, a new first paragraph was added to the MULCHING (GRASS HAY OR STRAW) note. The title of the note was revised to MULCHING (GRASS HAY OR STRAW) FOR TEMPORARY STABILIZATION.

On Sheet D6, the title of the TABLE OF MULCHING (GRASS HAY OR STRAW) note was revised to TABLE OF MULCHING (GRASS HAY OR STRAW) FOR TEMPORARY STABILIZATION APPLIED AT 2 TONS/ACRE.

On Sheet D6, the products and manufacturers were removed from the HYDRAULIC STRAW MULCH note. A note was added stating that this item will be from the approved products list and a link to the approved products list was also added.

On Sheet D7, the products and manufacturers were removed from the SOIL STABILIZER note. A note was added stating that this item will be from the approved products list and a link to the approved products list was also added.

On Sheet D9, the products and manufacturers were removed from the FLOATING SILT CURTAIN note. A note was added stating that this item will be from the approved products list and a link to the approved products list was also added.

On Sheet D13, the products and manufacturers were removed from the SEDIMENT CONTROL AT INLETS WITH FRAMES AND GRATES note. A note was added stating that this item will be from the approved products list and a link to the approved products list was also added.

On Sheet D13, the products and manufacturers were removed from the SEDIMENT CONTROL AT TYPE S REINFORCED CONCRETE DROP INLETS note. A note was added stating that this item will be from the approved products list and a link to the approved products list was also added.

On Sheet D13, in the DEWATERING AND SEDIMENT COLLECTING note, a paragraph was added stating that the dewatering and sediment controls products will be from the approved products list and a link to the approved products list was also added.
